<b>5. Type of Incident:</b> The incident began on April 15, 2011, when severe storms, flooding, and tornadoes struck portions of Alabama. A second, more severe weather outbreak moved across the northern portion of Alabama during the early morning hours of April 27, 2011, with tornadoes, severe thunderstorms, hail and damaging straight line winds. Later that same day, numerous super-cell thunderstorms produced long-lived strong to violent tornadoes across the northern two-thirds of Alabama. The National Weather Service (NWS) official assessment has confirmed that 20 of the 62 tornadoes that struck the State of Alabama were rated EF1 to EF5 on the Fujita Scale.

FEMA-1971-DR-AL will officially close October 15, 2011 and transition in the same location to the FEMA-1971-DR-AL Program Processing Center (PPC) on October 17, 2011.

Long-Term Community Recovery Center (LTCC) in Hackleburg will close on October 31, 2011 and in Rainsville on November 5, 2011.

Voluntary Organizations Active in Disaster (VOAD) Warehouse Tuscaloosa closes November 5, 2011.

A total of \$72,581,631 has been approved for Individuals and Households Program (IHP) and \$68,959,458 has been disbursed. Eight hundred and sixty-seven (867) IHP Max Awards have been approved for a total of \$26,191,095.

Registration for funeral assistance is 352 as of COB October 12, 2011 and of that 164 requests approved for a total of \$1,112,290.

There is one (1) inspector in the field as of October 12, 2011; 50,250 inspections have been issued with 50,248 returned for 99.9 percent completion.

A total of 366 Requests for Public Assistance (RPAs) were submitted to the State; 388 RPAs were logged into data entry and 388 were entered into Emergency Management Mission Integrated Environment (EMMIE). One thousand nine hundred ninety two (1,992) Project Worksheets (PWs) were received and entered into One thousand three hundred forty three (1343) are obligated for \$104,330,509.

**Community Education Outreach (CEO):**

Staff posted six (6) success stories, drafted thirty (30) success stories with nineteen (19) submitted to Headquarters (HQ).

**Hazard Performance Analysis (HPA):**

CEO writers have conducted 29 interviews and drafted 30 success stories. Of these 19 have been submitted to Headquarters, 17 have been posted on the FEMA website, and 9 have been published in FEMA Weekly.

Mitigation advisors counseled a total of 6,712 disaster survivors.

Outreach advisors have staffed 31 Lowes Stores (Autauga, Calhoun, Colbert, Cullman, DeKalb, Elmore, Etowah, Jefferson, Lauderdale, Limestone, Madison, Marshall, Morgan, St. Clair, Shelby and Tuscaloosa Counties); 38 Big Box Stores in Autauga, Blount, Calhoun, Chilton, Cullman, Etowah, Jackson, Jefferson, Lauderdale, Madison, Marshall, Morgan, St. Clair, Shelby, Talladega, Tallapoosa, Tuscaloosa, and Walker Counties for a total of 69 building supply stores. Outreach advisors approached 128,119 and counseled 82,437 survivors. Of these, 3,755 were referred to DRCs/DLOCs or the FEMA Hotline for assistance.

**Hazard Mitigation Assistance (HMA):**

HMA obligated 22 HMGP projects. The request includes 14 residential safe rooms, 2 community safe rooms, and 1 siren upgrade for a total of \$751,897. Nine (9) applications were received from the state from the following counties: DeKalb, Franklin, and Walker. These applications are for 80 residential safe rooms and 1 community safe room.

During the current operational period, FMI completed 53 flood reviews, conducted 290 site visits to determine the latitude and longitude of proposed residential safe rooms and 38 topographical maps for HMA HMGP projects. To date FMI staff has completed 1,060 flood reviews, 1,251 site visits to determine the latitude and longitudes and 807 topographical maps.

FMI staff has met with 277 public officials or floodplain managers out of 277 (100%) in NFIP participating communities in the impacted areas.



