## FEMA AWARDS MORE THAN \$2 MILLION TO ALABAMA FIRE DEPARTMENTS FROM THE ASSISTANCE TO FIREFIGHTERS GRANT (AFG) PROGRAM

**ATLANTA** – The U.S. Department of Homeland Security’s Federal Emergency Management Agency (FEMA) awarded \$2,038,177 from the Assistance to Firefighters Grants (AFG) program to local fire departments and emergency responders in the state of Alabama.

“Providing better equipment, training and staffing for fire departments across the country has one main goal—saving lives,” said FEMA Regional Administrator Phil May. “But everyone can do their part. Something as simple as changing the batteries in smoke alarms can save lives.”
