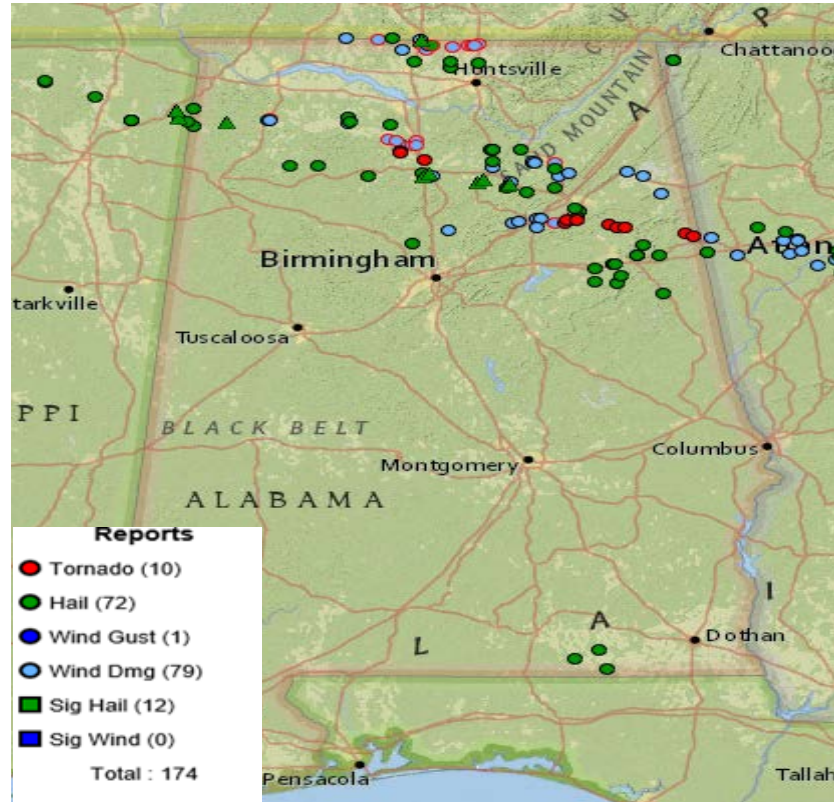

**INCIDENT UPDATE REPORT #4**



**WEATHER SUMMARY**

A powerful severe weather system produced a broken line of supercell thunderstorms and affected areas near and north of I-20 from 1 pm until approximately 1030 pm CDT on 3/19/18. This included numerous reports of quarter to baseball size hail, straight-line wind damage, flash flooding and tornadoes. The most intense damage was located near and north of I-20, and near and east of I-65, but damage also occurred in the northwest sections of the state. NWS teams will be surveying damage over the next several days to determine the numbers, paths and intensity of tornadoes across the northern sections of the state.

**STATE PARTNER ACTIONS**

**AEMA:** Communications Incident Support Unit deployed to Calhoun Co. to support Operations. Staff deployed to Etowah County and Calhoun County to support local response operations.

**Structural Engineers Association of Alabama:** Providing Engineers to Calhoun Co to access building stability throughout the county.

**Salvation Army:** Coordinating with Calhoun Co. to setup feeding for the command post. Feeding Operations for the public are ongoing at the Volunteer Reception Center. (3) Additional Mobile Feeding Units are enroute to Calhoun County.

**GOVS:** Volunteer Reception Center opened at 0700 @ Jacksonville Community Center and coordinating establishing a donation center.

**ADAI:** Conducting Damage Assessments (2) Food Inspectors in Jacksonville. Damage to Agriculture buildings in Limestone and Cullman Counties.

**AFC:** Deployed IMT Team and (6) chainsaw crews to Calhoun Co. Incident Command Post @ the Jacksonville Public Safety Complex.
